Professor Lynch has served as Senior Lecturer in Conservative Dentistry and Hon. Consultant in Restorative Dentistry and Postgraduate Course Organiser for the University of London where he was full time for 20 years (1980 - 2000).

Professor Lynch has been awarded more than 100 research grants, totalling over 6 million pounds and has more than 620 publications, including chapters in books and refereed abstracts. During his career, he has successfully supervised over fifty MSc, MPhil and PhD students and has been awarded several prizes for his research.


